## **CONFERENCE TERMS AND CONDITIONS**

"ETF" or "We" or "Us" means Eventing the Future 2024.

"Conference" means the Eventing the Future 2024 Conference to be held on 27 & 28 August at the Fly Palmy Arena.

**CONFIRMATION AND PAYMENT:** All applications to register for the Conference are subject to registrants making full payment through the Cvent platform or via bank transfer. You will receive a confirmation email shortly after you complete the registration process with your registration details and your tax invoice. Please check your details carefully and notify us immediately if there are any inaccuracies or further details to add (for example, dietary requirements) by email to: info@nzea.co. Once you have submitted your Conference fee payment, a receipt confirming your registration will be sent to you within five (5) business days of receipt of the payment. Admission to the Conference will not be granted unless the Conference fee payment has been received in full.

**Please note** that the Conference fee does not include any travel or accommodation expenses to attend which you must arrange independently. It is recommended that you arrange travel and medical insurance and ensure the policy covers cancellation of your attendance at the Conference, travel expenses and medical expenses, including any repatriation expenses, and any other Conference-related losses such as injury, damage to property or persons occurring during the Conference.

**CANCELLATION POLICY:** If your circumstances change and you can no longer attend the Conference, you may cancel your Conference registration by providing email notice to: info@nzea.co.

Our Conference fee refund policy is as follows:

- Registrations cancelled by Sunday 28 July 2024 will receive a full refund.
- Registrations cancelled between Monday 29 July 2024 and Sunday 11 August 2024 will receive a 50% refund.

- A. If any such events occur, ETF may postpone or cancel the Conference by notice to all attendees. In the event of cancellation, ETF will provide a refund of the Conference fee paid by attendees, less any expenses that need to be deducted for ETF's unavoidable expenses which have already been incurred.
- B. **COVID-19:** Due to the ongoing uncertainty resulting from the COVID-19 pandemic and the government-issued restrictions in response at any particular time or in any affected region, and the lack of reliable information to provide any reasonable expectation about when the COVID-19 pandemic risk is likely to subside in New Zealand, you agree that if the COVID-19 pandemic has escalated in New Zealand such that there are Government or Ministry of Health imposed restrictions (whether local or national) on travel, maximum meeting sizes or commercial and recreational activities that would apply to, limit, prevent access to or otherwise restrict ETF's ability to hold the Conference as planned on the scheduled date (COVID Event), then the terms of this section will apply (and take precedence over any other conflicting terms) and ETF may at any time prior to Tuesday 27 August:

- i. cancel the Conference upon providing written notice to all registered attendees, in which case ETF will provide a refund of the Conference fee paid, less any expenses that need to be deducted for ETF's unavoidable expenses which have already been incurred; or
- ii. elect to run the Conference in an online and On-Demand format only, in which case ETF will provide the necessary details to enable you and other attendees to register and participate in the Conference virtually; or
- iii. postpone the Conference to an alternate date.

## Please note:

- By registering for the Conference, you acknowledge and accept the possibility of the Conference being moved to an online format and also accept that this will not be valid grounds for requesting a refund of your Conference fee or any other fees, expenses or losses which you may incur as a result of such change. Your registration will be valid for both formats of the Conference.

- In the event the Conference is cancelled or postponed by ETF for Force Majeure or COVID Event reasons, ETF shall not under any circumstances be liable to attendees for any damages, costs or losses incurred in connection with the Conference such as transportation costs, accommodation costs or any other forms of financial loss.
